Crime in Progress

Dear Lieutenant Bridger,

I spoke to DFPS and they said to report the obstruction, retaliation (36.06) and witness tampering (36.05) to Crandall Police Department. If I don't, I can be charged with a crime (38.171).

Have I been vilified through improper influence (36.04)? Several things you said and asked clued me in:

- 1. You had no idea that I am an informant and material witness in the elder abuse financial exploitation case Helen Pauline Adams.
- 2. You don't know about an incident report (11-47789) I made 07/27/11 about threats, retaliation, with Lt. Bryan Simmons KSO (972) 932-9704 – a recorded conversation - about using police for an illegal eviction, TRO, false arrests, etc.
- 3. Your consistent indication that arrests would be made if any violence happened here.
- 4. You said you wouldn't NCIC me, like someone told you I would be afraid of it.
 - 1. I gave my DL to Nanette in December to run at the school and check me out before I would meet her. We had meetings with my pastor about my crime victim and fighter history. Butch Cummings
 - 2. A wedding in June (Nanette's son) was at the Red River Depot. Her X is the highest ranking civilian on the base. DL, dates of birth, were required to be given to him, or the groom (30), or the bride (28) – FACTA violation. IOW: Anyone on the pass around list could never prove identity theft in the future. I couldn't be on it with my bank security level. We contacted her X and an admin person there at the base so to do it privately, but they weren't compliant either – did not want to expose the offense to him on his son's wedding week! FACTA violations are \$3500 per incident (fed) + \$500,000 (Texas). So I stayed home. Ask Nanette about it. (903) 278-8850.
- 5. After everyone left, I noticed they removed the cutlery from the house.

The thing that got me was the statement of unethical man. Not that I take it personally, but I then realized that you don't know my part of the marriage with Nanette is equal shares in all my assets – intellectual property, securities over 36-years. The only reason I am broke is Howard Wayne Pittman, Jr. trashed the project launch 3-days into it. There is a lot more to it than this, but see if I come across.

This is not some little program like a copy of Win 7. Each copy is \$250k we are set to sell 5 per week. It's the first commercial grade (copyrighted) program in the world that sells cars/trucks by itself. This is the sales brochure: www.logic-sphere.com/dealer.

Howard was the sales manager and to be the president in the public company in a organizational meeting with the secretary, treasurer and me in Texarkana 07/16/11 (registered in the corporate book). Howard, a Lawyer, Jeff Collins (903) 908-0393, and I made 11 test conference calls (company phone log) with car dealers 07/22/11 to gather "inflight data" to write a COPE (client contact) program and launch it. During that time 2 people beat on the door hear to "check if Nanette is ok – all the way from Texarkana. On a case that is already filed. (previous obstruction including cutting the cable to this house, tell you later)"

07/23/11 Howard and I design the COPE in an online meeting. I hang up and check my email – see criminal activity (81 hits on a closed case) on Helen's case. Call Howard back and ask if he knows who it is to eliminate casual surfers... He starts questioning how I know there is a new ring of conspiracy... new attempt to get Helen's property... I told him that I filed the case with DFPS #58885459"

Howard, Stephanie Pittman (Nan's daughter), baby Sam & Jeff are scheduled to come spend the night because she has a job interview Monday in Dallas. They all cancel...

07/23/11 5:40 PM. Jeff, Kim, Howard make this Stockholder report via:

Hi Ken!

Hope you feel better today than yesterday and better yet tomorrow.

Jeff Collins, Howard Pittman, and I made 11 conference calls to Mercedes dealers in Arizona and California as a test. We had zero problems getting past the receptionists to the General Manager or GSM. We were able to speak directly with 5 GM's and 1 GSM – all with affirmative responses. We left a few voicemails which had no effect. We were not able to get the email link to them yet due to technical difficulties on our end.

All three of us a very satisfied with the responses and hope you are too. They were very positive. So now today I am constructing a small program, a client origination program emailer, that will be able to send the link with the proper coding on it while we are still on the phone with the GM (to ensure they received it).

All is pretty good here, Nanette says 'God Bless You', although I'm not so sure she has that power. lol I should be able to finish the program in a couple of hours and start the launch in the next few business hours after that. Probably be Sunday since it is so late today. I think that Sundays might be the best day to sell this. IOW: Catching a GM/GSM in the store on a Sunday is like waiting on a car customer in the rain/snow.

Next email should have a "Liftoff!" subject line which will start the clock for investor reporting. Kim

as required by corporate law. Ken Argent (408) 655-5139 is the spokesman for the investor group. He is in the hospital being treated for Septicemia (MERSA), almost killed him. This is the need for Howard and the new corporate officers.

Then I get this on Sunday 07/24/11 about 7:50 PM:

I'm sorry, but I can't agree to all the terms of your demands.

No need to apologize. I can understand why you might make such assumptions, and, as noted below, that you mis-read some of the original response as further detailed below.

No where in this letter do you state you have removed all my intellectual property from your computer. It do not have any intellectual property on my computer. It is all on your Websites, which is available to the public, or a Web 2.0 application for which I have never had access to code; nor do I have access to the working interfaces that a dealer would see.

You must also give me a reason for your demand be it retaliatory for reporting the crime, obstruction, witness tampering, other?

Immediately after our telephone conversation where you indicated you were stopping everythign because you suspected someone was investigating you, and prior to your letter offering a position in sales only, I decided I could not afford any more delays for any reason. My **singular** reason is that I choose to focus on my own business. It was my decision and my decision alone. I was not influenced by anyone in any manner.

And who are the "associates" you demand I never contact again?

If you will read what I wrote, <u>no such thing was written</u>. The demand for contact was in reference to me and my immediate family. My other associates have a mind of their own and can choose to do whatever they want.

I'll need to hear from each individual I have a business relationship with that they want nothing to do with this program and why before I stop my launch. IOW: the last I heard from everyone (HP Sr., Jeff, Mona, Brian) they were interested and pressing for a launch.

With exception of my Dad and brother, who will follow my lead, that is their choice.

Of course I reserve my rights under law and may not address this issue at this time.

As far as I am concerned you have no rights under law related to me or my associates or any choices we make regarding withdrawal from participation in

Logic-sphere.

None of us have signed contracts or non-disclosure agreements. I contributed time with verbal promise of reimbursement for work performed outside sales activities. What was is? Here it is in my notes: \$50,000.00 to do a Youtube video; 15% Sales Manager Commissions, \$5,000.00 per week for work performed outside sales.

I am finished with this.

Then I send this 07/25/11 4:24 PM:

Still unclear on whether or not you are demanding I cease contact with Howard Pittman Senior for the positions I spoke with him about. Strictly business. Howard Pittman is in your immediate family and an associate of mine. He made statements to me ensuring his knowledge and support of the project launch. To lose staff in the middle of a project launch is not only damaging, but devastating. I need to hear from him if he is following your lead, passing through on the conflict. I need to fill those positions to complete this project. Please answer so I know what to do. In addition, intellectual property is much more than just the software, so like last week when the conflict of interest first arose, you should eliminate all of it from your computer and not disclose any trade information to protect the company.

There are several items in your response that I disagree with, but I cannot address all of them at this time. One in particular I state perfectly clearly:

I did not stop work on the project Saturday at 12:10 because "someone new is investigating me". I stopped work on the project and called you back because someone new is perpetuating the crime against Helen (DFPS Case # 58885459) and adding witness tampering

(http://www.statutes.legis.state.tx.us/Docs/PE/htm/PE.36.htm#36.05) and obstruction or retaliation (http://www.statutes.legis.state.tx.us/Docs/PE/htm/PE.36.htm#36.06). I have weathered attacks physically, financially, mentally, my aged parents have been attacked, brother, friends, the spokesman for the project's investors, people you don't know, and others. Now, I have damages that cannot be reversed, and they are growing. As I write, that "somebody" is checking me out from Texarkana College wifi. Somebody is still not satisfied. Now they have contacted Harvey Sorenson, Esq. a defendant in a huge, ongoing Real Estate Investor Fraud Case in Sacramento. He has contacted my hosting service to see if his case can be removed. It can't, but he just reopened *his* case. See what I mean? It goes on and on.

The other reason I quit working on the Client Origination Program Emailer (COPE in L-S database) because there was no way to write it under corporate & securities laws. I have legal shareholders and must report frequently under law. The project is all about creating a lawful audited financial statement. The COPE program was for you and your associates to operate. Automation of your personal job tasks. Which is still true. It is also still true you have a conflict of interest. A conflict of interest is not a bad thing or an offense or sin, but it would be an offense of mine if I allowed it in the company structure during the organization. This is a big part of my fiduciary responsibilities to the shareholders. We could lose the whole thing, copyrights included, if there is a smidgen of impropriety during the organization. You can't be an officer or take over the whole project, but one or more of your associates can – then agree to pass the hat back to you when the conflict is over... In the meanwhile the project gets launched and we all make money and the investor reports are great. The audited statements are great. We can leverage them. So to stay legal, I reconstructed your position for the second time to eliminate the possibilities of conflict with the shareholders interests and made my report (including your & Jeff's 100% analysis of our initial sales call test (3...2...1)). I did that in less than 5-hours after talking with you last Saturday. You wouldn't take my calls or respond to my email until your letter below late Sunday night.

I feel that Howard Senior and any lawyer would understand this. Jeff did. Mona did. We all support you. Always have and always will. You made your decision. You are out. I understand that. Before I tear down the computer programs to remove you and your associates, I need to hear from them that they wish to be excluded. No heat... Just need to know for my investor report to Ken Argent, and rebuild the sales/support crew... Need a Sec/Treasurer, and corporate structure... Need to make a launch or report why I am not. That's fair isn't it?

This is why I am broke. No other reason. Never heard back from him until he walked in the door last night. Never heard from his "associates" who were copied on the Email. Got in touch with Mona Rigdon, (903)796-9597 a paralegal and she kept with me, but said Howard called to say he hated the way I handled the crime-set – filing against family... She told him I had to.... He talked her out of the job, I talked her back in (email)...

In Helen's case, my primary concern is her mental health. I suspected these I accused had vilified me to her. The case worker is Michele Anderson 903 826-2663, Supervisor is Sharon Young (903) 791-3326. I wouldn't let myself call her, in fear of this. This is in the records.

Material Facts:

In tape #28 – Howard mention's Helen has been tampered with. We were nothing but love before that. She fusses if I don't visit for a while.

I issued a letter of credit to Helen that I would pay any legal mortgage payment for her without equity, pay back or collateral 07/11/11 to stop the illegal action – sent it to Howard, who did not pass it on, I put it in her hand 07/16/11. 07/11/11 I also Hired Jeff Collins to meet with Helen, her POA's in person 07/20/11 11:00 AM – we were all on the phone together, including Helen. When the defendant's got rid of Jeff, probably by Howard, that's when I filed.

Also in #28 – Howard specifically states he is there because I filed charges against his wife and I shouldn't have done that...

He also states he's here to protect his mother-in-law. From what? Me filing additional information on discovery? Violence? Why? There is no reason for breach in the eviction petition. I'm no hand-writing expert, but it looks like he filled it out and she signed it. (There are other errors).

He and Nanette specifically ask for the key – even after you left. Then the tort on the phone missing car key. Then I say do I need to call CPD back? And he makes the call.

Also, Nanette and Howard say in the tape that they have heard from Mona about Inside business information.

I just heard from my brother who says my brother-in-law and sister (Both MD's) have been contact by someone from the group, a women, who told them lies and looking for dirt on me. Upsetting them terribly. My parents have been contacted. (92 & 86) I keep a distance from my family to protect them.

My thinking is Stephanie Howard's wife, is behind the whole thing and is taking over the fiduciary, or the deed. This makes the third attempt.

I think Howard is trying to have me arrested, put out so I can't finish my work... Happens a lot. Forensic evidence show they all checked me out and everything was fine, way before this happened. Now they claim to all I'm no good and if you think so – you're out.
